Dr. ERNESTO ARAGON y GODOY, 233 East 69th St., NYC, Secretary to Dr. JOSE MIRO CARDONA, of the Consejo Revolucionario de Cuba (CRC), advised on 7/18/62, that he had been to Washington, D. C. on 7/11 and 12/62, to confer with representatives of the United States Department of State (S) (u)

ARAGON advised that at the Department of State he had conferred with ROBERT HURWITCH, whom he stated was recently promoted to a position with the title of General Coordinator of Cuban Matters, and that HURWITCH is now located on the sixth floor of the State Department and has a private office next to Undersecretary of State for Latin America, EDWARD MARTIN. ARAGON also advised that while at State Department, he spoke with H. GODFREY SUMM, Chief of the Cuban Desk. (S) (u)

ARAGON advised that the question regarding the training of Cuban Army officers has been resolved, and that invitations are out for former Cuban Army, Navy, and Air Force officers to attend advanced officers training schools in the United States. ARAGON advised that the original plan was to invite 40 former Cuban officers from each branch of the military service, but that State Department has decided that this would be too many as no country has 120 officers in school at one time and may lead to rumors and furnish material for Cuban UN Ambassador Dr. MARIO GARCIA INCHAUSTEGUI to bring charges in the UN against the United States. As a result of this consideration, ARAGON stated that State Department has now decided that 12 officers from the Army, 12 from the Navy, and 12 from the Air Force will be invited to attend in the immediate future and the courses will be for a period of 10 or 12 weeks. ARAGON advised that it was also decided that after this group of officers is trained, another group will be called. (S) (u)
