Dr. ERNESTO ARAGON GODOY, 233 East 69th Street, NYC, Delegate of the Consejo Revolucionario de Cuba (CRC), advised on 11/4/62 that he went to Washington, D.C. on 10/21/62 at the request of the U.S. Department of State in order to be present in Washington for conferences with various US. officials relative to Cuban developments.

Dr. ARAGON stated that he departed from Washington, D.C. on the afternoon of 11/3/62 but had to be in Washington by noon of 11/5/62 in order to be present for a special meeting of the Organization of American States (OAS) which was going to hear a protest and proposal by the Government of Argentina and possibly a protest by the Government of Venezuela.

ARAGON advised that due to the present crisis relative to Cuba and the fact that there might be developments in Washington which would, in his opinion, necessitate his getting in contact immediately with the Bureau, he desired to be placed in contact with a Bureau representative in Washington rather than wait until he again returned to New York.
