Doctor FERNANDO ARAGON Y GODOY, 233 East 69th Street, New York City, the former delegate of the Consejo Revolucionario de Cuba (CRC) was interviewed by the New York Office on 5/22/63. Since Doctor JOSE MIRO CARDONA resigned as head of the CRC, ARAGON has spent a great deal of his time closing out matters of the CRC in Miami, Washington and New York. ARAGON at the present time is looking for employment.

Doctor ARAGON on 5/22/63 advised that in connection with the recent difficulty between MIRO CARDONA and the KENNEDY Administration, he, ARAGON, felt that MIRO CARDONA was 95% correct but was wrong in the manner in which he handled the incident. ARAGON also stated that he has a feeling that MIRO CARDONA was merely a tool in a fight over policy between the United States Department of State and the Central Intelligence Agency (CIA). ARAGON advised that he had no definite proof for the above statement but has the general impression, which he got from dealings with representatives of both the State Department and CIA.
