ReNYtel to Bureau 1/12/62 captioned as above, and NY
airtel to Bureau 1/22/62 captioned "DR. ERNESTO ARAGON, PSI-CUBA".

Enclosed herewith for the Bureau is a copy of the
document which was presented before the Inter-American Peace
Commission of the Organization of American States by Dr. JOSE
MIRO CARDONA, head of the Revolutionary Council. Dr. MIRO CARDONA
presented this document before the OAS on 12/26/61. ReNYtel cap-
tioned as above reflected that this document was already in the
possession of the U.S. Department of State but had not yet been
made public.

This document was forwarded to the NYO by Dr. ERNESTO
ARAGON, secretary to Dr. JOSE MIRO CARDONA.

ReNYairtel dated 1/22/62 captioned "DR. ERNESTO ARAGON,
PSI-CUBA", reflected that ARAGON left NYO on 1/19/62 for Miami,
Florida where he would meet Dr. MIRO CARDONA and then proceed
to Montevideo and Punta del Este, Uruguay. Prior to departure,
ARAGON advised that he and Dr. MIRO CARDONA were making this
trip under instructions from the U.S. Department of State.
