IS-CUBA'.

Dr. HERBERT A. MARCH, 233 East 67th St., NY, Secretary
to Dr. JOSE MARIO GARCIA, head of the Cuban Revolutionary Council,
advised 2/20/62 that he was departing NY on 3:05 p.m. flight for
Washington, D.C. to meet Dr. JOSE MARIO GARCIA, who was leaving
Miami at 3:45 p.m. for Washington, D.C. for talks with government
officials in Washington. MARCH stated that Prime Minister MARCH
GARCIA announced on television on evening of 2/19/62 that trials
for the invasion of the April 17, 1961 invasion would begin on
2/20/62.

MARCH advised that MARIO GARCIA had called RICHARD
HEBERGER of the U.S. Department of State and advised of his plans
to come to Washington and HEBERGER told him to come ahead. MARCH
stated that Dr. GARCIA, during his visit, will attempt to have a
conference with President JOHN F. KENNEDY and will also talk to
members of the Latin American countries who have not yet broken
