On December 22, 1960, MM 492-S* informed that he knows of no questionable activities on the part of the subject, stating that so far as he knows, subject has been busily engaged in the selling of gasoline and other products at his service station located on SW 8th Street, Miami, Florida. He said subject was recently interviewed by a representative of Miami television station WCKT, Channel 7, Miami, in which he made a statement in broken English concerning his financial plight after departing from Cuba, stating he had lost everything after being forced to flee Cuba (u)

On December 22, 1960, MM 726-S* also informed he had noted no unusual activities on the part of subject and had observed him to be taking care of his service station. (u)

Miami will continue to follow and report activities of the subject and a report will be submitted to the Bureau by January 10, 1961.
