~~RE~~ TWO THREE SIX ONE DASH C ASTERISK ADVISED SUBJECT WAS VISITED BY ONE GEORGE LEWIS PAREN PHONETIC END PAREN, WHOSE SPEECH SOUNDED <sup>AS THOUGH HE WERE</sup> NEGRO. INFORMANT STATED LEWIS ASKED SUBJECT'S HELP IN RECOVERING SOME MONEY, THE DETAILS OF WHICH WERE NOT CLEAR. INFORMANT STATED AFTER LEWIS LEFT, SUBJECT TELEPHONICALLY CONTACTED BEN ANDERSON, SERGEANT, ATLANTIC CITY POLICE DEPARTMENT, AND TOLD HIM HE HAD BEEN VISITED BY LEWIS IN CONNECTION WITH QUOTE THAT SHARP THING END QUOTE.
