According to the Informant this meeting was also attended by two unidentified individuals.

Informant stated that he did not know the purpose of this meeting.

DE T-5 advised on May 22, 1963, that DOMINIC PETER CORRADO had recently stated that he had attended a meeting which was attended by JOE SERILLI, WILLIAM TOCCO, JOHN PRIZIOLA, ANTHONY and VITO GIACALONE and LEO GANCI. The Informant stated that it is his opinion that the meeting took place at GANCI's home which is located on 24 Mile Road near Gratiot Avenue, St. Clemens, Michigan. Informant stated that CORRADO indicated to him that the same group has had meetings of this sort previously and all of the meetings take place in the early afternoon. The Informant stated that CORRADO did not tell him the reason for this meeting.

DE T-6 advised on May 27, 1963, that VITO GIACALONE had arranged to meet with ANTHONY SERILLI and MICHAEL POLIZZI at 4:00 pm on that date. According to the Informant they were to meet at a boat, the name of which was unknown to the Informant. It was the Informant's opinion that they were to meet with DOMINIC PETER CORRADO.

B. Barbute

DE T-1 advised on May 4, 1963, that VITO GIACALONE had arranged for a reserve location for the barbute game in Highland Park, Michigan. According to the Informant this place was located on Hamilton Avenue and the building was owned by some type of Syrian organization. The Informant stated that it had a balcony, a main floor and a basement.

On June 14, 1963, SA JOHN L. SHELBOURNE observed a building described as above located at Tunedo and Hamilton, Hazel Park, Michigan.

DE T-1 advised on April 15, 1963, that VITO GIACALONE intended to open a barbute game in Detroit. This game would operate on Friday, Saturday and Sunday. According to the Informant, GIACALONE had stated that this barbute game would be located at 130 West Montclair, Detroit, in the Rex Hotel.
