UNIDENT says it was the work of the Communists and [SEVILLA] says that he spent part of the day at the Department of State so that they would get the inside on what happened down there. The phone is then passed to the second UNIDENT whom [SEVILLA] addresses as "Minister". CS

[Minister] asks [SEVILLA] if it will be possible for him to try to obtain an increase in the [Nicaraguan sugar quota] for the first semester of 1963 noting that under the new [sugar law] the President of the United States can distribute some 150,000 tons of sugar to nations which are deemed friendly to the USA. [Minister] stipulates that [SEVILLA] is not to request an increase in the quota for this year because [NICARAGUA] can still export some 12,000 tons under the quota for this year while it has only 40,000 on hand. [Minister] advises that he has written to DILLON and [SEVILLA] says he will contact DILLON personally on this noting that DILLON is the only Republican holdover in the KENNEDY Cabinet and describes DILLON as being a very good person. (S) SEVILLA then discusses with the (Minister) the fact that he has heard that the lawyers and notary publics in (Nicaragua) whom he describes in a cutting manner as "cultured persons" are planning to lead a strike against (President SOMOZA) because they feel that their status may be lessened by new legislation under consideration (in Nicaragua). (S) SEVILLA states that this is very serious because this is the professional segment of the populace which is agitating with the (Conservative Party) against (SOMOZA) and adds that President KENNEDY is aware of what (SOMOZA) is doing to try to implement the Alliance for Progress (in Nicaragua). SEVILLA expresses his concern because criticism of the government is being broadcast over the radio and can be heard (S) in the most remote part of the country and indicates that (SOMOZA) has not seen fit to put in adequate control over the transmission of "lies" and "slander" over the air which he describes as much more dangerous than the printed word.

(S) SEVILLA then refers to a trip planned by (the Minister) to (Costa Rica), Mexico and to New York City in connection with loans being sought by Nicaragua under the Alliance for Progress. The (Minister) advises (S) that (ALFREDO SEVILLA) should arrive here at the end of the week and that the "Other person" should be there by the end of the month. They discuss various tactics connected with the loan and (SEVILLA) suggests that they look for donations rather than loans as was done by Honduras and another country. (S)
