FRED G. RANDACCIO, the number one man for STEVE MAGADDINO, contacted STEVE MAGADDINO for advice as to what action he should take against SAM QUARCINI, who had been working with the police. RANDACCIO had been unsuccessful in getting QUARCINI to come to Buffalo.

It is noted that QUARCINI, a Niagara Falls, N. Y., gambler, has been active in union affairs in Niagara Falls and operating without the sanctions of STEVE MAGADDINO. SAM QUARCINI is also a criminal informant, having symbol number BU 259-C.

9/18/62

JOSEPH TODARO, aka "Lead Pipe Joe," operator of the LaNova Pizzeria, complained to VINCENT A. SCRO that JAMES MUFFOLETTO, Deputy Commissioner of the New York State Liquor Authority, Buffalo, N. Y., has been holding up his application for a Liquor License for more than five months. TODARO relates that MUFFOLETTO had indicated that certain parties had to be taken care of before TODARO could get his Liquor License. TODARO was advised by SCRO that if he could not get satisfaction from any other source, he should take these problems up with STEVE MAGADDINO or consider contacting a cousin of SAM RANGATORE, who is on the New York State Liquor Board in New York City.

9/24/62

A meeting was held in the office of VINCENT A. SCRO to discuss the sale and distribution of treasury balance tickets in the Western New York area. Those present were identified as STEVE MAGADDINO, VINCENT A. SCRO, PASQUALE NATARELLI, FRED G. RANDACCIO, JAMES V. LA DUCA and CHARLES A. MONTANA. During the meeting, NATARELLI advised MAGADDINO that FRANK DOMINIC BAGOZZI, of Syracuse, N. Y., could get a couple of big treasury balance accounts in Pa. and N. J., since LOUIS COHEN had died in Pa.
