DOMINIC C. LONARDO

The following information was received from the St. Louis Office on May 24, 1963:

A review on May 21, 1963, by IC EARL M. RANEY of the military service records on file at the Military Personnel Records Center, St. Louis, Missouri, for a one DOMINIC CHARLES LONARDO, Serial Number 15 071 155, indicated he served in the United States Army Air Corps from November 7, 1941 to January 30, 1942, at which time he was honorably discharged as an Aviation Cadet at Pine Bluff, Arkansas, by reason of a flying deficiency, Deviation, right septall, 30 per cent obstruction.

He also served in the United States Army Air corps from September 29, 1944 to June 12, 1946, under the same serial number and was honorably discharged as a Technical Sergeant at Rome, Italy to accept employment with the United Nations, Relief and Rehabilitation Administration, Italian Mission, Rome, Italy.

The following information was received from Los Angeles on May 23, 1963:

On May 20, 1963, C. STEVENS, Investigator, Douglas Aircraft, Long Beach, California, advised that all employment records during the years 1940 have been destroyed.

On May 14, 1963, the records of the Long Beach, California Credit Association and Long Beach, California Police Department, contain no record identifiable with DOMINIC CHARLES LONARDO.

On April 29, 1963, Mr. RALPH KREIGER, Cleveland Enforcement Chief, Ohio State Department of Liquor Control, 1300 West 9th Street, Cleveland, Ohio, advised SA JOHN J. BARRETT that the liquor license for the Frolic Bar, 814 Vincent Avenue, Cleveland, Ohio, is in the name of Frolics, Inc., 814 Vincent Avenue, Cleveland, Ohio. According to his records, the stockholders in Frolics, Inc., are as follows:

KREIGER stated that previously the sole stockholder in Frolics, Inc., according to his record, was DOMINIC C. LONARDO but that on March 26, 1963, the Ohio State Department of Liquor Control approved the purchase of a one-half interest in Frolics, Inc., by MAX BROOKS.

KREIGER stated that his records reflect that BROOKS purchased his interest in Frolics, Inc., for \$25,000 which amount
