Re Detroit letter to Cleveland, dated August 9, 1963, captioned "ANTHONY JOSEPH BESASE, AR".

Information has been received in Detroit from

DE 919-C* that ANTHONY (TONY) GIACALONE and a person referred
to as "TOLEDO" were discussing DOMINIC CORRADO and his
business capabilities. In the discussion TONY GIACALONE
stated he could not criticize DOMINIC CORRADO. "TOLEDO" is
believed to be ANTHONY "WHITIE" BESASE of Toledo. This
individual stated neither DOMINIC nor his brother, TONY,
were capable of shining the toe of their father's shoe. (This
information has already been furnished to the Bureau and
Cleveland and caution should be used in disseminating this
information.)

DE 868-C-TE was contacted by SA BARRON T. CONKLIN on 9/26/63, and was asked if there had been any trouble between DOMINIC CORRADO and TONY GIACALONE. Informant furnished the following information:

Last January DOMINIC CORRADO made the decision that from now on the winning number in the numbers operation in Detroit would not be changed and no matter what number might come up this number would be paid off. ANTHONY GIACALONE was very much opposed to this decision. Profits in the numbers operation in Detroit have almost disappeared and have caused the numbers operation of the Italians to be cut back and the number of employees cut. As a result of this, TONY GACALONE has been critical of this decision by DOMINIC CORRADO.
