H. Miscellaneous

The records of the Treasury Department, United States Coast Guard, Security Pass Section, 21 Trently Place, Brooklyn, New York, as furnished by JAMES LAWRENCE to SA VICTOR CAPELLI on November 5, 1959, reflect that the subject made application for a Coast Guard Port Security Card on February 11, 1958, for permission to work on the waterfront, and furnished the following information on the application as of that date:
