POLITICAL MATTERS

RE MEXICO CITY TELETYPE TO THE BUREAU, DATED JUNE 14, 1976. (U)

AS REPORTED IN REFERENCED TEL; ON MAY 27, 1976, GUATEMALAN NATIONAL POLICE UNCOVERED AN EXTREMELY LARGE CACHE OF WEAPONS IN THE FACTORY SANTONI, WHICH IS OWNED BY CAPTIONED SUBJECT IN GUATEMALA CITY. FOUR INDIVIDUALS WERE ARRESTED AND HAVE REPORTEDLY CONFESSED THAT SUBJECT WAS THE LEADER OF A GROUP WHICH WAS CONSPIRING TO OVERTHROW THE PRESENT GOVERNMENT OF GUATEMALA (GOG). [THE U.S. EMBASSY IN GUATEMALA CITY (S)

RECEIVED UNOFFICIAL WORD THAT SUBJECT IS RESIDING IN THE MIAMI, FLORIDA AREA. BY COMMUNICATION DATED JUNE 14, 1976, THE REGIONAL SECURITY OFFICER, GUATEMALA CITY, ADVISED THAT GOG AUTHORITIES HAVE RECEIVED RELIABLE INFORMATION DURING THE PAST SEVERAL MONTHS THAT TWO AMERICANS, ROBERT HEMMING, AND HIS BROTHER GERALD "JERRY" PATRICK HEMMING, ARE INVOLVED WITH ZIMERT IN
