On July 8, 1963, RONALD VON KLAUSSEN, 1612 Michigan Avenue, Miami Beach, Florida, telephone number JE 8-4937, appeared at the Miami Office of the Federal Bureau of Investigation and stated he is a member of the Veterans of Foreign Wars (VFW) Post #1608, located at 1608 S.W. 27th Avenue, Miami, Florida. He stated that this VFW Post had undertaken the task of training a group of Cuban exiles known as the Antonio Maceo Battalion. VON KLAUSSEN said that according to one of the officers of the Post, the training is being sponsored by Central Intelligence Agency. (CIA). (u)

VON KLAUSSEN said he had also been advised that the names and photographs of all Cubans being trained were being forwarded to the FBI for clearance.

VON KLAUSSEN continued that he is presently providing some of the instruction for the Cubans. He said he is concerned that his name and photograph would be forwarded to the FBI, because about ten years ago he was convicted of attempted assault in New York City.

MM T-1, who has been involved in Cuban revolutionary activities for the past two years, advised on August 6, 1963 that RONALD VON KLAUSSEN, 1612 Michigan Avenue, Miami Beach, Florida, had recently contacted GERALD PATRICK HEMMING, Miami, Florida. MM T-1 explained

RONALD VON KLAUSSEN

HEMMING is an adventurer, mercenary and soldier of fortune, who has been involved in Cuban revolutionary activities for the past 4 years. VON KLAUSSEN told HEMMING he was then attempting to purchase arms for Cuban revolutionists in Miami and that he had funds available to make these purchases.

On August 8, 1963, MM T-1 advised that HEMMING and his group of mercenaries and adventurers had concluded VON KLAUSSEN is completely unreliable, mentally unstable and psychotic. VON KLAUSSEN claimed that he could obtain thousands of Sten guns from Canada, was going to buy some B-29 war surplus airplanes, and that he was going to bring this great quantity of arms and other materials to Miami.

MM T-1 stated that HEMMING and his group have been trying to deal in arms for a long time and know the difficulty there is in trying to locate even a small quantity of small arms. VON KLAUSSEN has recently become Military Instructor with the Antonio Maceo Battalion and hangs around the VFW Post located at 1608 S.W. 27th Avenue, Miami.

On September 24, 1963, MM T-1 advised that VON KLAUSSEN had recently been seen with another American and again stated he was then interested in purchasing arms. The other American was identified only as ALY ~~CARTER~~. FLA

On October 13, 1963, RONALD VON KLAUSSEN, 1612 Michigan Avenue, Miami Beach, was interviewed in connection with another matter. VON KLAUSSEN volunteered he was a former U.S. Army Airborne Ranger and served with

unidentified representatives of the MRR told VON KLAUSSEN that they were interested in purchasing automatic weapons, had funds available but were unable to locate any such weapons. VON KLAUSSEN immediately recontacted HEMMING, advised him of the situation and the opportunity to earn a profit by obtaining automatic weapons, and selling them to the MRR. HEMMING immediately contacted different friends and sources of arms, but was unable to locate any automatic weapons.

On November 21, 1963, MM T-1 advised that VON KLAUSSEN recently contacted ~~SANTIAGO~~ ALVAREZ, 541 N.W. 45th Avenue, Miami. *FLA.* ALVAREZ is the head of Comandos L, an anti-CASTRO organization that has conducted raids against Cuba in the past. VON KLAUSSEN told ALVAREZ that he had a source who produced a compound called Thermite, which compound burns at a very intense heat and could be used for sabotage. ALVAREZ stated he was interested in purchasing this material but ~~at the~~ present time could not afford it and did not have adequate funds to make any purchases of this type.

MM T-1 explained that Thermite is made by ~~LARRY~~ DE JOSEPH, who operates a general store at Sweetwater, Florida, and who is a friend and associate of GERALD PATRICK HEMMING.

On January 9, 1964, MM T-1 advised that there has been a split in the Antonio Maceo Battalion and VON KLAUSSEN continues as a training instructor for one of the factions.

On January 20, 1964, MM T-2, an American, advised he had been in Miami, Florida, for about seven
