A CUBAN. GORMAN TOLD AGNEW HE (AGNEW) WOULD MEET MARIO FONTELA

ALFONSO, CHIEF OF PRESS AND PROPAGANDA FOR THE FRENTE OBRERO REVOLUCIONARIO DEMOCRATICO CUBANO (FORDO, CUBAN REVOLUTIONARY DEMOCTRATIC WORKERS' FRONT). AND OTHERS WHO WOULD BE PRESENT AT THE MEETING TO DRAFT THE PROTEST, GORMAN SAID HE HAD TELEPHONED OTHER NEWSPAPER MEDIA IN MIAMI BUT NO INTEREST HAD BEEN SHOWN. AGNEW ADVISED GORMAN AT 11:15 P.M. ON 18 APRIL THAT HE (AGNEW) COULD NOT GO TO MIAMI TO COVER THE MEETING.

- ON 19 APRIL AT 8 A.M. GORMAN ASKED AGNEW TO COVER ANOTHER MEETING SCHEDULED FOR THAT AFTERNOON OR EVENING. AGNEW FLEW TO MIAMI AT NOON IN HIS PRIVATE PLANE AND WAS PICKED UP AT THE TAMIAMI AIRPORT BY GORMAN AND THREE UNIDENTIFIED CUBANS AND TAKEN TO THE 14TH AVENUE APARTMENT. HOWEVER. THE SECOND MEETING HAD MEANWHILE BEEN CANCELLED AFTER FONTELA WAS CONTACTED FOR QUESTIONING BY THE FEDERAL BUREAU OF INVESTIGATION (FBI).
- 3. GERALD PATRICK HEMMING AND HOWARD K. DAVIS ARRIVED AT THE APARTMENT TO PICK UP GORMAN.
