Enclosed are 9 copies of a letterhead memorandum
dated and captioned as above, at Miami.

MM T-1 is MM 639-S, Miami file 134-238-Sub A.

For the info of the Bureau, MM 639-S telephoned the
Miami Office at approximately 10:10 PM, 10/9/61, to report that
he was with GERALD PATRICK HEMMING and DICK WHATLEY, both of
Interpen, at the home of Dr. SANCHEZ ARANGO. It was there that
MM 639-S learned of the existence of the dynamite stored in
downtown Miami, and he inspected it along with HEMMING and
WHATLEY. Upon discovering its highly dangerous condition, he
immediately notified this office and was instructed, for reasons
of preserving his own security, on insisting that SANCHEZ ARANGO,
HEMMING or WHATLEY immediately notify the FBI or the police of
the location of this dynamite, in order to avoid a public
catastrophe.
