Review of Albany indices concerning names set forth in referenced communications failed to develop any positive information with the exception of LCN reports prepared by the New York Office, which contain references to CLYDE GEORGE SMALDONE, CLARENCE M. SMALDONE, EUGENE SMALDONE and PAUL CLYDE VILLANO, all of whom are known or suspected LCN members within the Denver Division. It is noted that this same information was disseminated to both Miami and Denver.

Albany TE member sources have been repeatedly contacted regarding captioned matter and AL 3983-C-TE has advised that RUSSELL A. BUFALINO (BUFALINO LCN Family) knew the deceased victim very well. Source was unaware of details of BUFALINO and ROSELLI's relationship, other than both are LCN members. Source advised that the only reference to ROSELLI's death was that of ANTHONY FRANK GUARNIERI (BUFALINO LCN Caporegima), who commented that ROSELLI "probably went to far," a reference which source assumes was made to ROSELLI's having testified before the Senate Select Committee on Intelligence (SSCI).
