With regard to ROSSELLI's alleged interest in an automotic key making machine, inquiry ass made at Interstate Vending Company, Los Angeles, California, and it was learned that this company is currently negotiating a contract with SAE REISHER of Sents Fenica, California, For exploitation of such a machine. It is recalled that ROSSELLI said he was dealing with the inventor of this machine; that Interstate Vending Company, was also interested and that ROSSELLI wanted to keep Interstate Vending Company from getting a contract with the inventor.

SAM REISHER, Osco Company, 2306 East Colorado Deulevard, Sante Monice, Galifornia, advised on 2/7/63, that he is the inventor of an automatic key making machine and has been working on it for several years; that since he comploted the machine, numerous investors have looked into the possibilities of emploiting the machine; that he does not know NOSSELLI and does not recognize MOSSELLI's photograph as a person who was interested in investing in the key machine. One of the parsons the made inquiries re the machine, in the summer of 1962, was SOL RISENROD of the investment brokerage firm of Thomas J. Minston & Co., Reverly Hills, California. Information has been reported in the ROSSELLI investigation that BISENROD and ROSSELLI are acquainted.

RELIGIER advised that he would be alert for any indiention that ROSSELLI is interested in his key machine. He added, however, that he is in the final stages of negotiating a contract with Interstate Vending Company.
