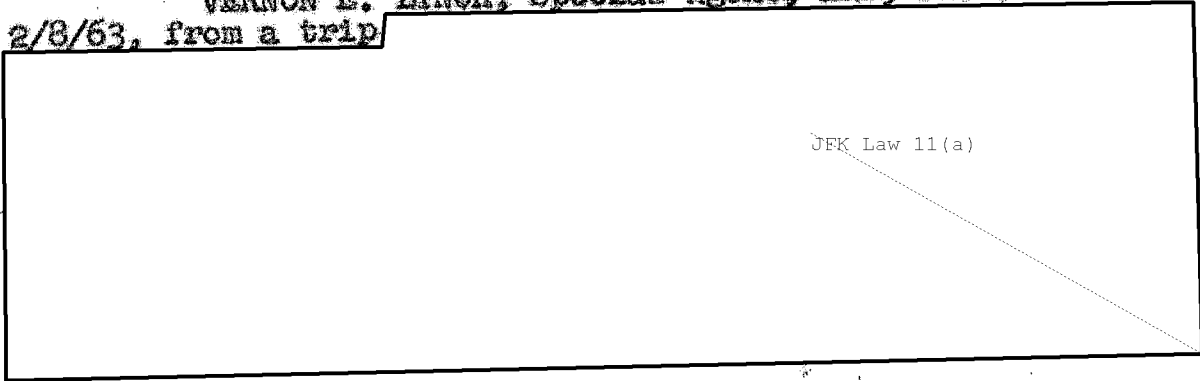

With regard to ROSSELLI's alleged interest in an automatic key making machine, inquiry was made at Interstate Vending Company, Los Angeles, California, and it was learned that this company is currently negotiating a contract with SAM REISNER of Santa Monica, California, for exploitation of such a machine. It is recalled that ROSSELLI said he was dealing with the inventor of this machine; that Interstate Vending Company was also interested and that ROSSELLI wanted to keep Interstate Vending Company from getting a contract with the inventor.

SAM REISNER, Osco Company, 2906 East Colorado Boulevard, Santa Monica, California, advised on 2/7/63, that he is the inventor of an automatic key making machine and has been working on it for several years; that since he completed the machine, numerous investors have looked into the possibilities of exploiting the machine; that he does not know ROSSELLI and does not recognize ROSSELLI's photograph as a person who was interested in investing in the key machine. One of the persons who made inquiries re the machine, in the summer of 1962, was SOL EISENRUD of the investment brokerage firm of Thomas J. Winston & Co., Beverly Hills, California. Information has been reported in the ROSSELLI investigation that EISENRUD and ROSSELLI are acquainted.

REISNER advised that he would be alert for any indication that ROSSELLI is interested in his key machine. He added, however, that he is in the final stages of negotiating a contract with Interstate Vending Company.
