He has circulated the story that he was kidnaped by the TBI in New York City and was taken by them to Washington, D. C. for questioning. DALITZ and DONNELLEY both are in agreement that BRINSMADE is a "GD Liar," and that he has fabricated the whole story to cover up for the \$10,000.

DONNELLEY, DALITZ, and ALLARD ROEN, a Desert Inn Hotel executive, are all in agreement that it is now becoming fashionable to look down on people who are operating in the gambling induancy. [They discussed warious bills which were introduced in Medert Bession of the Nevada Legislature. They considered several of these bills devrimental to industry and feel that they were defeated only through efforts of GEORGE DELIM. Executive Secretary of Las Vegas resort hotel association. ROEN made the observation that many people in the industry are becoming fed up with Governor GRANT SAWYER, Governor of Nevada. They feel that he is favoring DEL WEBB, whom they feel is operating without restrictions in the state of Nevada, and is creating a monopoly. ROEN described SAWYER as a "jerk and a SOB." (It is noted in regard to Governor SAWYER, that he checked into the Desert Inn Hotel on 4/22/63 for indefinite stay and according to LV 10-C, instructions were issued that his entire account was to be complimented.)

One of the bills introduced in the legislature provided that after a hotel had filed their return, if gaming authorities did not agree that the return represented a true account of their business operations, that the Board could then arbitrarily set a figure on which they had to pay taxes. DONNELLEY stated this bill was written with the idea that money was being taken out of the state without being properly accounted for and without taxes being paid on this money. Neither ROEN or DALITZ commented on DONNELLEY's observation.

DALITZ stated he had been contacted on the previous day by a man who indicated he could furnish DALITZ information which would save \$200,000. In exchange for this information, this unnamed individual wanted only \$10,000 in cash. DALITZ stated he talked to this individual for sometime and made an appointment to talk to him the following day. In the meantime,
