RE ATLANTA TELETYPE TO BUREAU AND MIAMI, NOVEMBER 1, 1976.

ON DECEMBER 14, 1976, AT 4042-OC ADVISED THAT AS A RESULT OF A RECENT TRIP TO MIAMI HE HAD NOT BEEN ABLE TO OBTAIN SPECIFIC INFORMATION CONCERNING CAPTIONED MATTER; HOWEVER, HE WAS IN RECEIPT OF INFORMATION THAT A BENSON LYNCH, BELIEVED TO BE A WHITE MALE AND PRESENTLY IN FEDERAL CUSTODY IN ATLANTA, MAY HAVE KNOWLEDGE OF CAPTIONED KILLING.

INFORMANT ADVISED PEOPLE IN MIAMI AREA WERE VERY RELUCTANT TO DISCUSS THIS MATTER.

ATLANTA INDICES NEGATIVE RE BENSON LYNCH.
