KENNEDY is speaking in the morning or afternoon on Friday before the General Assembly. (TSAO) said he does not know but will call (LI) when he finds (S) out. HE asked (LI) if he is still staying at the hotel and (S) (LI) said that he is. (TSAO) said that it is very difficult (S) to get tickets for FRIDAY.
9:48	AM	IC	(W5906-209) JDM (S) Male named "CAL" spoke to (JOHN HSING) re car repairs. In (S) the course of conversation, (HSING) remarked that he is (S) getting a little fed up working like this year after year and not getting any further ahead. He stated that he would probably be better off in the restaurant business as much (S) as there is no money in what he is doing now. (HSING) said (S) he has been doing a lot of thinking lately. "CAL" told him to be careful not to make a move until he has something definite in mind.
