Enclosed are copies two serials from Hong Kong file 190-0. The transfer of these serials is directly due to an indices search at Headquarters of Hong Kong's manual indices.

The manual indices search also indicated 89-00 and 62-49 contained information regarding the JFK assassination. Upon review of files in Hong Kong, it was determined 89-00 contains only general information regarding assassinations, nothing specifically relating the the JFK assassination. File 62-49 was destroyed in September, 1980, authority is not known.

Hopefully, this information satisfies Bureau request.
