Dear Ms. Keeley:

This is in response to your letter dated May 30, 1997, requesting Commission review of portions of one unclassified FBI document (FBI File No. 105-100081-155, MM Report, dated 12/18/64, two pages consisting of pages one and four of the document) and of one FBI document classified SECRET (FBI File No. 105-100081-81, HQ Airtel, dated 04/23/63, two pages consisting of pages one and two of the document). You indicated that the review was being sought to determine whether any information contained in the designated portions should be deleted prior to permanent transfer of the documents to the National Archives. You ask that we cite the relevant provisions of the John F. Kennedy Assassination Records Collection Act (JFKARCA) with regard to any deletions deemed appropriate and advise you whether classification is still warranted. For internal procedural Commission accounting purposes, your request was handled as a Freedom of Information Act (FOIA) request with the above number assigned.

We have reviewed the portions of the documents referred to above and have determined that no deletions are necessary or appropriate. With regard to classification, we do not see any need for the portions of the SECRET document to be classified. We note, however, that the Commission does not have original classification authority, but only derivative authority based on prior classification actions by other agencies. Thus, we defer to the FBI regarding any continuing need to maintain SECRET or other classification on the one classified document referred to above. All of the documents sent to us are being returned and are enclosed.
