**DETAILS:** On 4/21/94, the JFK Task Force transferred an additional 146,778 pages of JFK documents to the NARA. This brings the total number of pages transferred under the "President John F. Kennedy Assassination Records Collection Act of 1992" (the Act) to 331,085.

The majority of the documents transferred, 92,245 pages, were from the JFK Assassination investigation file maintained at FBIHQ. Only 1641 pages of these documents contained postponements. The postponements ranged from one word or item on a page to more extensive postponements. Two hundred nineteen pages were postponed in their entirety. An additional 406 pages were withheld because the Task Force is awaiting word from another federal agency or foreign government on whether information they contain can be disclosed.
