NO 1457-C-TE advised that CARLOS MARCELLO returned to New Orleans after absence from the city this past weekend and his whereabouts when gone unknown to source. Source advised that CARLOS MARCELLO had a dinner party at his home Monday night for some politicians, whose identities source does not know at this time. Source advised that one of the individuals is a candidate for assessor for Jefferson Parish in the upcoming election.

Source also advised that Parish President TOM DONELON and State Senator HANK LAURICELLA had a dinner party at the Elmwood Plantation last Saturday night (this establishment is run by CARLOS' brother JOSEPH) and reportedly this dinner party was free of charge.

Mr. DAVID CHANDLER, representative of Life magazine in the State of Louisiana, advised that CARLOS MARCELLO agreed to pose for pictures for Life cameramen but refused

PURPOSE:

To report information furnished by L. H. Harrelson, a Potential Confidential Informant (PCI) of our Chicago Office, and a polygraph examiner for Keeler Polygraph Institute, Chicago. Information relates to Perry Russo and Mrs. Sandra Hoffett McMaines, ex-girl friend of Russo and polygraph examinations given them by Harrelson's source. This recommends source's information be paraphrased and summarized and disseminated to Attorney General.

BACKGROUND:

New Orleans District Attorney James C. Garrison in his investigation of the assassination of President Kennedy has alleged a conspiracy for this purpose existed between Clay Shaw, a retired New Orleans businessman, David Ferris and Lee Harvey Oswald. Perry Russo and Sandra Hoffett McMaines allegedly were present in Ferris's apartment and heard discussions in this regard. Russo was Garrison's principal witness against Shaw in 3/67 following which Shaw was indicted for conspiracy to assassinate President Kennedy.

It was subsequently disclosed that Russo was subjected to drugs and hypnosis prior to his testimony, for which Garrison has been criticized. It has also been disclosed that Mrs. McMaines was contacted in Omaha, Nebraska, by representatives of Garrison's office and strongly urged to return to New Orleans to give testimony.
