Re Paris letter 7/27/60.

This case was discussed with ERNEST BUEHLMANN of the Swiss Federal Police on 8/12/60 and 9/22/60. He advised that considerable investigation had been conducted to locate the Albert Schweitzer College in Switzerland, since this college was previously unknown, and there was no official record of its existence in the Federal Government records in Bern. He stated that they have now located the Albert Schweitzer College at Churwalden, Switzerland, and that investigation is presently being conducted there in accordance with the Bureau's request.

This will be followed with the Swiss Federal Police, and the Bureau will be advised.
