PURPOSE:

To emphasize need for protection of Solo assets and instruct that all unclassified Solo information for release under FOIA, civil litigation, or to any non-FBI employee, be cleared with Intelligence Division (INTD) personnel prior to material being released from FBIHQ. (u)

DETAILS:

ON 4/1/99 (JFK)

The Solo operation is a very complex matter involving a network of high-level assets. (See attached for identity of Solo assets.) Numerous FOIA and civil litigation cases are currently pending and the possibility exists that this operation could be compromised. It is necessary to take extra precaution to protect information furnished from these assets and, as a general rule, all information should be classified. If it is the judgment of FOIA, Legal Council Division or other employees who may be processing information for release to non-FBI personnel, that information furnished by a Solo asset should not be classified or withheld from the requester, the material must be cleared with CI-1 Section, INTD. (u)

The only exception to above procedure would be where a Solo asset was used to characterize an individual as being a CPUSA member and other informants previously identified the individual as a CPUSA member. (u)

INFORMANT - Excise informant symbol numbers: informant file numbers (134-, 137-, 170-); any information tending to identify informant; a person requesting confidentiality; and any identifying information as to source requesting confidentiality. T-symbols are not excised.

THIRD AGENCY - ^{Federal} Excise the names of all third agency personnel and all information disclosed through discussion or through a review of their files. The name of the third agency is not excised.

FOREIGN INTELLIGENCE AGENCY - Excise the name of the foreign agency and all information disclosed. ^{ONLY} SEE REMOVAL SHEETS - 3RD AGENCY (RCMP)(S)

POLICE INTELLIGENCE - Excise the names of all U. S. law enforcement intelligence personnel. - ^{ONLY} leave P.D. info. ^{NOT FBI OR JUSTICE PERS.}

SENSITIVE TECHNIQUES - Excise any mail openings. - Elec. Secur.
