Subject : EXEMPTION OF SYSTEMS OF RECORDS UNDER THE PRIVACY ACT

PURPOSE: To revise the Federal regulation which exempts FBI systems of records from certain provisions of the Privacy Act.

SYNOPSIS: The FBI has exempted seven of its seventeen systems of records from certain provisions of the Privacy Act, 5 U.S.C. § 552a. The seven systems of records are:

- 1) National Crime Information Center (NCIC) (JUSTICE/FBI-001)
- 2) Central Records System (CRS) (JUSTICE/FBI-002)
- 3) Electronic Surveillance (Elsur) Indices (JUSTICE/FBI-006)
- 4) Criminal Identification Record System (CIRS) (JUSTICE/FBI-009)
- 5) National Center for the Analysis of Violent Crime (NCAVC) (JUSTICE/FBI-015)
- 6) FBI Counterdrug Information Indices System (CIIS) (JUSTICE/FBI-016)
- 7) National DNA Index System (NDIS) (JUSTICE/FBI-017)
