**Synopsis:** (U) Request the issuance of permanent unescorted building pass for Ms. Marie B. Fagnant.

**Enclosures:** (U) Memorandum dated June 23, 1997 from the Assassination Records Review Board (ARRB) forwarding the Top Secret security clearance for Ms. Fagnant.

**Details:** (U) The John F. Kennedy Assassination Records Collection Act of 1992 mandated that all federal agencies process their records related to the assassination and provide all the original documents to the National Archives for public review. The FBI has been working with the ARRB established by this act to complete the project. Other ARRB employees have access to the FBI building to accomplish this job.

(U) The ARRB, advised the JFKTF that Ms. Fagnant would be reviewing FBI records in the JFKTF space and will need access to the FBI building on a daily basis. She has her Top Secret clearance and should be allowed access to the FBI's JFKTF. On 6/23/97, the ARRB advised telephonically that Ms. Fagnant would begin reviewing documents 6/24/97, due to the limited time left for completion of the project. The JFK Task Force requests that the review of her clearance be expedited, so the Board's or the Task Force's work is not disrupted for an extended period of time.
