Synopsis: To advise the Security Unit, Personnel Division (PD), the Security Programs Manager (SPM), National Security Division (NSD), FBI Headquarters (FBIHQ), has approved the captioned individuals unescorted access to the J. Edgar Hoover (JEH) Building.

Administrative: Reference is made to Electronic Communication (EC) from Ms. Keeley, Office of Public and Congressional Affairs JFK Task Force, dated 04/23/1998.
