Synopsis: Report results of requested search.

Enclosures: Enclosed for OPCA, JFKTF is the original Dallas file 105A-DL-67296 consisting of one volume regarding Lee Harvey Oswald.

Also enclosed are original serials from Dallas file 89A-DL-60165 accumulated since the original serials were last provided on June 24, 1994. These serials are enumerated 190 through 283.

**Details:** A full search of the automated indices to the central records system of the Dallas Division failed to locate any records regarding Marguerite Oswald, Marina Oswald, Michael Paine, Ruth Paine, or George De Morenschildt.

The automated indices reflects one FOIA request regarding Jack Ruby (190-DL-59862) and no reference to Jacob Rubenstein. The automated indices also reflect FOIA requests regarding Ruth Paine (190-0-792), and David Ferrie and Clay Shaw (190-DL-61087).

The automated indices reflect the enclosed Dallas file 105A-DL-67296 regarding Lee Harvey Oswald as well as three FOIA requests (190-DL-59976, 190-0-691 and 190-0-815).

A search of the automated indices failed indices failed to locate any new references for John F. Kennedy or the John F. Kennedy Assassination; however, the original serials from the pending Dallas file regarding the John F. Kennedy Assassination that have not previously been furnished are enclosed for information.

According to Former Acting SAC James F. Adams, this office does not maintain any tickler files or archived SAC material. Adams advised that all information regarding the assassination has previously been furnished to FBIHQ. Any information concerning the assassination is coordinated by CDC Gregory. (The Dallas Division currently uses

Personnel Clerk Amaryllis McDonald advised that this office does not maintain any tickler files or archived SAC material. Further, any such information handled by the RAs would be maintained in Headquarters City. McDonald advised that all Assassination information has been previously released to FBIHQ.

It is noted that the Automated Indices of the Dallas Division is an index to all records created since 1986. The Resident Agencies as a part of the Dallas Division do not maintain a separate records system.

A search of the Administrative files revealed no listing regarding any of the listed individuals or the Assassination. Further, there is a listing for each RA individually. A review of these files determined they regard administrative matters such as space, security, and executive staff visits.
