Howard:

The attached letter to the Director, (Hartingh's opened copy attached), delivered yesterday from the JFK Review Board, advises of determinations to disclose records. A seven-day period for appeal to the President exists, per this letter. The details of the documents at issue have been set forth in John A. Hartingh to William E. Baugh, Jr., memorandum dated 9/6/95, which recommended against appeal but that CID and NSD advise you if they recommend appeal.

The Task Force has been advised that CID deferred to NSD because the records at issue relate to their work and that NSD recommends against appeal.

The only difference between Hartingh's memo and the attached letter is that the Board did not address document #6 in Hartingh's memo as the Board has apparently tabled that document instead of ordering it released. With this change, CIA advises they do not plan to appeal the release of their information in FBI documents, but they will advise the FBI by formal letter within the timeframe for appeal.

Please advise me or John Hartingh if we may assist you further in this matter.
