MEMORANDUM FOR ROBERT M. BRYANT FEDERAL BUREAU OF INVESTIGATION

SUBJECT: (XXX) JFK Assassination Review Records: Release of Information from FBI Investgations of Foreign Officials Establishments

- (S) At your request, the Department of State has reviewed FBI documents (attached list) relating to investigations of diplomatic officials and establishments.
- (U) Solely from the standpoint of our bilateral relations the Department of State has no objection to release of the redacted information pertaining to Finland, Poland, Czech Republic, Former Republic of Yugoslavia, Cuba, China, Yemen, Romania, and Hungary.
- (S) The Department <u>continues</u> to oppose release of <u>any</u> material including the non-redacted portions, that would damage US foreign relations by revealing FBI collection of information involving Israeli diplomatic personnel, other Israeli officials, and US citizens conducting routine contacts with Israelis. We believe that the government of Israel would react quickly and negatively to the release of such material.
- (S) With respect to the Dominican Republic, the Department agrees with the FBI determination that the redacted information should not be released. There is a new government in the Dominican Republic and acknowledgment that the US collected information as a result of FBI investigation of foreign diplomats could cause that new government substantial embarrassment and hinder ongoing sensitive negotiations on a range of issues important to the United States government. $\left(\frac{\partial C}{\partial x} \frac{\partial C}{\partial y} \frac$
