Title: Assassination Materials Disclosure Act of 1992

Synopsis: New York is requested to forward the document requested below to the JFK Task Force (JFKTF) as soon as possible due to an extremely short deadline.

Enclosures: Copy of teletype originating in Miami.

Details: Pursuant to the John F. Kennedy Assassination Records Collection Act of 1992 (JFKARCA), any materials considered assassination records must be made available to the National Archives and Records Administration (NARA) in their original form. The JFKARCA defines how the FBI may now postpone certain information, but the originals are still sent to the NARA, to be maintained until the year 2017 when they are to be opened in full.

Since the original will be sent to the NARA, a copy of the serial should be made for record purposes prior to shipment to FBIHQ. The serial should be received at FBIHQ no later than C.O.B. 9/15/98.

Please search New York's records for any copy of the attached teletype originating in Miami and forward the original document from New York's files to FBIHQ, JFK Task Force, Attention: Catherine L. Lamey, Room 11144.
