Title: JFK RECORDS COLLECTION ACT OF 1992 (The Act)

Synopsis: Submission of PG files to FBIHQ/JFK task force.

Administrative: Reference is made to Bureau Electronic Communication (EC) dated 09/24/1996; and telephonic conversation of Edward R. Lomb and LuAnn Wilkins on 09/26/1996.

Enclosures: Enclosed for FBIHQ are four (4) boxes containing PG files 92-226 and 92-228.

Details: This matter was discussed with LuAnn Wilkins on 09/26/1996. A decision was made to submit all files pertaining to these two investigations rather than the three sub-files listed on page two of referenced communication.

For the information of FBIHQ, Pittsburgh file 92-226 is an investigatory file on Sebastian John La Rocca. Electronic surveillance in this case was in a form of a misur (microphone) which was place at North Star Cement Block Company located at 12 McCandless Avenue, Pittsburgh, Pa. This misur was assigned symbol number PG 622-C with initial authorization issued on 01/26/1961. This misur was activated on 02/07/1961 and was discontinued on 10/08/1964.

Pittsburgh file 92-228 is an investigatory file on Samuel Mannarino. A misur (PG 713-C) was activated on 03/06/1964 at the private office of Samuel Mannarino located at Ken Iron and Steel Company, 1263 Third Avenue, New Kensington, Pa. This surveillance was discontinued on 07/22/1964.
