On 6/24/97, the indices of the San Francisco Office were searched and no record was located in the confidential, or elsur indices. ACS indices had 2 references:

1. 190-SF-87450-162 This is the San Francisco control file for Elsur checks requested by HQ for FOIPA requests. HQ advised it was not necessary to send this reference in.
2. 149-SF-106204(SD)-304 This is a San Diego reference to the UNABOM case file. On 7/1/97, the Unabom data base was searched and no record identical to Judith Campbell Exner was located.
