**Title:** (U) JFK ASSASSINATION RECORDS  
COLLECTION ACT (JFKARCA)

**Synopsis:** (U) On 12/2/1996, the Assassination Records Review Board (ARRB) formally advised by letter to the FBI their determinations on FBI documents. The FBI has a limited mandated time in which to appeal these decisions.

**Details:** (U) On 12/2/1996, the ARRB formally advised the FBI of the determinations voted by them on FBI documents at a meeting held 11/14/1996. The ARRB letter listed 108 documents for which the ARRB made determinations. The FBI agrees with the ARRB's determination to postpone or open information in 33 of the documents. Of the remaining 75 documents are the ARRB decisions not within the scope of the FBI's document release policies. The release of the information in these documents will reveal the identities of 129 individuals whom the documents described as potential criminal informants (PCI), criminal informants (CI), potential security informants (PSI), security informants (SI), and confidential sources (CS). The ARRB decisions will also release classified foreign counterintelligence information.
