On 2/11/60, SA W. HARLAN BROWN received in person a typewritten report from DL-7-S, dated 2/11/60, and which has been serialized as 134-4A-309.

Informant advised that on 1/18/60, the regular Dallas CP meeting was held at the home of JOE and MARGARET LANDIN, 2230 Roanoke Street, Dallas, Texas. Those present were BILL LOWERY, RUTH LOWERY, AUGUSTIN ESTRADA, and the LANDINS.

Informant advised that BILL LOWERY said he would discuss the CP's recent national convention. He volunteered to do this because he was the only one receiving the "WORKER." ESTRADA told him that the discussion would be his "assignment," since he thought that only by having "educationals" could the local CP be brought up on its feet. AUGUSTIN ESTRADA suggested that they have an "educational" at every one of their future meetings. The members agreed to this, and the discussion of the National Convention of the CP would be their first educational.

Informant said he learned that BILL LOWERY inquired as to how HAROLD and BETTY MANN stood with the Party; that he had recently looked for them and failed to find them, but had located HAROLD MANN's father, who told him where the MANNs lived. BILL LOWERY said he would make an effort to locate them soon, as he wanted to know their status, because at almost all of the State Committee meetings inquiries were made of the Dallas group concerning the MANNs' status. LOWERY asked, were they or
