On July 6, 1960, DL-7-S, in person, furnished a typewritten report dated July 6, 1960, to SA W. HARLAN BROWN, which report has been serialized as 134-4A-331.

That report stated that on Wednesday, 7/6/60, the regular Dallas CP meeting took place in Farmers Branch, Texas, at the home of AUGUSTIN ESTRADA. Those present were: MR. and MRS. BILL LOWERY, MR. and MRS. JOE LANDIN, and AUGUSTIN ESTRADA. At this meeting BILL LOWERY discussed the letter he had received from the founder of the G.I. Forum, DR. HECTOR GARCIA. BILL LOWERY reported that at the G.I. Forum meeting on Tuesday night, JOE MOLINA seemed reluctant to do anything in the TREVINO case and his reactionary attitude toward the case kept others from freely expressing themselves. By a very small margin, he added, the membership voted to have a committee consider DR. GARCIA's proposals. Enough members volunteered to form a committee to do just that.

That report also reflected that JOE LANDIN has been requested by BILL LOWERY to print 200 copies of the original letter GARCIA mailed him. JOE LANDIN said he could have it printed on Friday. LOWERY said that a copy of the letter would be given to each of eleven organizations in Dallas. A letter of explanation will be attached to GARCIA's letter. The Forum will ask these organizations to help form the Vincent Trevino Memorial Committee. Once this committee is formed, with at least two delegates from each organization, it will be on its own, separate from the G.I. Forum.
