On 6/28/60, SA W. HARLAN BROWN received a typewritten report from DL-6-S in person, dated July 26, 1960, and which has been serialized as 134-1A-524.

That report stated that ALBERT GONZALEZ called JOE LANDIN and told him that P. R. OCHOA, publisher of the newspaper "The Dallas American," had called him a number of times. GONZALEZ and LANDIN called on OCHOA and learned that OCHOA is interested in GONZALEZ because he (GONZALEZ) is Precinct Chairman of 166. OCHOA told them that poll tax payees had decreased in that precinct and he was glad GONZALEZ had replaced MASON, a Negro. OCHOA further advised them that through his newspaper he had campaigned against MASON. He is strongly against integration, is for States rights, and belongs to the White Citizens Council. OCHOA and GONZALEZ had a heated discussion on integration, the law of the land, the Catholic Church, GI Forum and Latin-American organizations. OCHOA said the States rights are above the Supreme Court's interpretations, and added that Negroes should never be allowed to dominate the South; that they would take over, replace Texanos in their jobs, and that integration is the worst thing that could happen.

This report reflected that GONZALEZ and LANDIN said they wanted only to uphold the U. S. Constitution, be morally right and think of human dignity. These things, OCHOA exclaimed, are not important, when the showdown came they had to look out for themselves, not help the Negroes gain Black supremacy. They should help to elevate their own people who were under the yoke of the Clergy, Avila's Mexican Radio Program and Latin-American organizations. GONZALEZ related to him some cases of discrimination against Americans of Mexican descent. He mentioned a swimming pool
