On 7/8/60, DL-6-S, in person, furnished a hand-written report to SA W. HARLAN BROWN, dated 7/5/60, which report has been serialized as 134-1A-526.

That report stated that BILL LOWERY phoned JOE LANDIN and asked LANDIN to translate a letter he had received from DR. GARCIA, written in Spanish. GARCIA in his letter told of how one VINCENTE TREVINO had been shot and killed in an altercation with a policeman, which was unjustified and unnecessary. GARCIA in this letter identified himself as the State Chairman of "THE VINCENTE TREVINO MEMORIAL COMMITTEE." He urged the Chairman of the Dallas Forum to help form a similar committee in Dallas. GARCIA also stated that it is necessary for all Texas towns to have these committees for "the price of liberty is eternal vigilance." In this letter DR. GARCIA outlined some steps the committee should take.

That report also reflected that BILL LOWERY thanked JOE LANDIN for his help and said he would take the case to the Forum that night, their regular meeting night. He was thinking of suggesting a dance, the profit going to the TREVINO family.
