On 8/30/60 SA W. HARLAN BROWN received, in person, a hand-written report dated 8/29/60 from DL-6-S. This report has been serialized as 134-1A-541.

Informant determined that on 8/29/60 a regular meeting of the Dallas CP took place at AUGUSTIN ESTRADA's home. Present at this meeting were AUGUSTIN ESTRADA, BILL LOWERY and JOE LANDIN. MARGARET LANDIN and Mrs. ESTRADA went to visit a neighbor.

Informant determined that AUGUSTIN ESTRADA explained to BILL LOWERY that he had not made the trip to Houston as he was sick on Saturday afternoon and decided not to go. He stated he had been working out in the sun and believed he had a touch of sunstroke. He did not call BILL LOWERY because he knew he couldn't go to Houston, and JOE LANDIN, AUGUSTIN continued, had committed himself to attend a picnic sponsored by the Young Democrats. (Later that night JOE LANDIN explained to BILL LOWERY that he visited AUGUSTIN ESTRADA on Saturday morning at his job and suggested they leave for Houston at 9:35 P.M., by bus. ESTRADA agreed, then at about 5:00 P.M., ESTRADA went to LANDIN's house and told him he would pick him up at about 8:45 PM. From there they would catch the bus. At 9:00 PM, however,
