On 9/13/60, SA 559-S furnished the writer an oral report which was subsequently transcribed and thereafter acknowledged by informant on 9/22/60. This report is located in 134-29A-561 and contains the following information:

It was learned that on 9/6/60, TED CASTILLO contacted JOE LANDIN in Dallas, Texas, at the LANDIN residence. CASTILLO told LANDIN that he wanted to see AUGUSTIN ESTRADA. LANDIN made arrangements for CASTILLO to contact ESTRADA. LANDIN told CASTILLO that BILL LOWERY had resigned as Chairman of the G. I. Forum. LANDIN was generally irritated or dissatisfied with LOWERY and stated that he pussyfooted around issues and never takes a stand. LANDIN told CASTILLO that ESTRADA was selected to
