On 9/20/60 SA W. HARLAN BROWN received in person, a hand-written report from DL-6-S, dated 9/19/60. This report has been serialized as 134-1A-544.

Informant determined there was a regular CP meeting on 9/19/60 at 2230 Roanoke, Dallas, Texas, with the following present: JOE and MARGARET LANDIN; BILL LOWERY; and AUGUSTIN ESTRADA.

BILL LOWERY reported he had contacted ELWOOD ROSS recently and ROSS told him that he would contact 12 persons and ask them for a \$5.00 donation, which funds would go to JOSE ESTRADA, ex-Dallas CP member who was deported to Mexico. These 12 persons include DAN YARBOROUGH. ELWOOD ROSS suggested that BILL LOWERY collect \$50 from other people to match his collection.

BILL LOWERY added he would not be at the State Committee meeting but suggested that JOSE ESTRADA's case be brought up at the meeting by the Dallas group. Each club, he said, should have a
