On 9/22/60, SA W. HARLAN BROWN received in person a typewritten report from DL-7-S, dated 9/20/60, which has been serialized as 134-4A-340.

The above-mentioned report reflects that the regular CP meeting was held 9/19/60, at JOE LANDIN's home. Present were Mr. and Mrs. LANDIN, BILL LOWERY and AUGUSTIN ESTRADA.

BILL reported that ELWOOD ROSS was going to get \$5 from 12 persons to be turned over for the JOSE ESTRADA fund. ROSS suggested that LOWERY collect the same amount to match his.

BILL explained he would not attend the State Committee meeting on Sunday, Sept. 25, as his sister was visiting him. He suggested that the case of JOSE ESTRADA be brought up at the meeting and that each club be urged to form a fund for ESTRADA. He added JOSE should receive letters from most of them. He wanted JOSE's address to give to EL and NATALIE ROSS.
