On 11/15/60, DL-7-S, in person, on 11/15/60, furnished a typewritten report to SA W. HARLAN BROWN, dated 11/15/60, which has been serialized as 134-4A-349.

That report reflected that a regular meeting of the CP was held at the home of JOE LANDIN, 2230 Roanoke Street, Dallas, on 11/14/60. Those present were: JOE and MARGARET LANDIN, BILL LOWERY, and AUGUSTIN ESTRADA.

It was determined by informant that BILL LOWERY reported that on his latest trip to Fort Worth he had tried to register the people there in the Communist Party. Those he referred to were BETTY and HAROLD MANN, COLUMBUS MARTIN and his wife, MC KINNEY and MC KINNEY's friend, JOHN. LOWERY reported that HAROLD MANN said he would not join until the day came when he would be safe in identifying himself as a Communist. BETTY MANN was quoted as saying she would not register because she did not agree with democratic centralism, and was not at all satisfied with the expose of STALIN after his death. JOHN, MC KINNEY's friend, was quoted as saying he would think it over. COLUMBUS and his wife complained
