On 2/6/61 SA JOHN W. FAHN received by mail a typewritten report from DL-16-S, dated 2/4/61. This report has been serialized as 134-44A-464, and contains the following information:

On 2/3/61 HAROLD MANN called COLUMBUS MARTIN by telephone to inquire whether or not McKINNEY FRETWELL had gotten in touch with MARTIN to ask what part FRETWELL could play in the GONZALEZ race for U. S. Senator. MARTIN told MANN that FRETWELL had not called.

HAROLD MANN inquired of MARTIN also whether the latter had seen GILBERT GARCIA lately and whether they had discussed politics. MARTIN told MANN that he had seen GARCIA but had been unable to talk to him because at the time GARCIA was engaged in talking to another man.

According to DL-16-S, MARTIN went to GARCIA's cleaning establishment in the 1700 block of Evans Avenue, Ft. Worth, Texas, on 2/4/61. At the time MARTIN arrived, GILBERT GARCIA was not in and MARTIN talked to GARCIA's brother. MARTIN called later and talked to GILBERT GARCIA who said he was preparing to go to Victoria Texas, to attend a statewide meeting for GONZALEZ at which meeting Senator GONZALEZ would be present. GARCIA was quoted as having said that EVERETT HUFFMAN would accompany GARCIA to Victoria, Texas, to meet Senator HENRY GONZALEZ. GILBERT GARCIA also told MARTIN that HUFFMAN was a "good man" and that he was "glad to have HUFFMAN as the treasurer of the Ft. Worth GONZALEZ Club."

GILBERT GARCIA also told MARTIN that HUFFMAN was spending \$10 on having some GONZALEZ cards printed.

HAROLD MANN told MARTIN (on 2/3/61) that a CP meeting would be held at the MANN home at 3:00 PM, on 2/4/61 (1423 Clinton Street, Ft. Worth).
