On 2/13/61, DL-7-S, in person, furnished SA W. HARLAN BROWN a typewritten report, which was dated 2/13/61, and has been serialized as 134-4A-362.

That report reflected that on Monday, 2/6/61, JIMMY TRUJILLO visited JOE LANDIN at his place of employment. The report also reflected that TRUJILLO recently contributed 1,000 handbills to the American G.I. Forum, and that TRUJILLO had seen a letter on the death penalty that LANDIN was going to send to the local newspapers. JOE LANDIN, according to informant, asked TRUJILLO that since he was interested in the ERNESTO M. LOPEZ case if he wanted to send in the letter and TRUJILLO said he did.

Informant learned that TRUJILLO told JOE LANDIN he had been to Victoria, Texas, and he and FRANKLIN GARCIA had met with Senator GONZALEZ, San Antonio Commissioner ALBERT PENA, and G. I. Forum founder DR. HECTOR GARCIA. That GONZALEZ has given TRUJILLO the "go sign" in organizing a committee to support him. It was also determined by informant that TRUJILLO had learned in San Antonio that COPE had endorsed MAURY MAVERICK 39 to 46 and that COPE was willing to give some financial aid to GONZALEZ, but it was refused. In the meantime FRANKLIN GARCIA, AFL-CIO member cannot support GONZALEZ. LANDIN told TRUJILLO it would be up to him (TRUJILLO) to head the committee for Gonzalez. JOE LANDIN suggested "ONWARD WITH GONZALEZ or FORWARD WITH GONZALEZ for the name of an organization.

Informant had no additional information.
